1.0 GENERAL TERMS

- 1.1** In accepting the role assigned to your child, you will on behalf of your child or guardian agree to the following terms and will ensure your child/guardian is also aware of and understands these terms:
- 1.2** Services will be provided to the Western Sydney Wanderers FC (Club) without pay, to the best of the participants abilities, with due care and skill and in accordance with any Club directions and policies notified from time to time;
- 1.3** The apparel or uniform as provided by the Club must be worn while performing the volunteer services;
- 1.4** Expenses directly relating to volunteer services will be reimbursed only if I have obtained the prior written consent of Club and submit appropriate receipts or documentation;
- 1.5** All confidential information or material concerning the Club or its competitions or teams, including team movements, player information and any other information specified by the Club as confidential, must be kept confidential and not disclosed to any third party. This obligation survives the expiry or termination of the appointment for any reason;
- 1.6** To presently assign to the Club all existing and future intellectual property rights in materials, works or other deliverables created by volunteer (whether on own or with the Club or its contractors or volunteers) in the course of supplying voluntary services (Deliverables). I will, on request by the Club from time to time, supply to the Club one copy of the Deliverables in their then current state;
- 1.7** Personal property (such as bags and money) must be kept safe and I acknowledge that the Club is not responsible for any lost, stolen or damaged personal property;
- 1.8** That my child/guardian will not do anything to compromise their own safety or the safety of others and I understand that there may be risks associated with providing particular volunteer services;
- 1.9** Not to use, or refer to, the names or logos of the Club or its competitions or teams without the Club's prior written consent, including in public speaking activities or promotions. I agree not to speak to the media on any issue relating, directly or indirectly, to the Club or the position.

2.0 TERMS OF PARTICIPATION

- 2.1** The Club will take all reasonable steps to safeguard the welfare of all participants in the event.
- 2.2** You (the parent or guardian) acknowledge and agree to your nominated child or the child you are in charge of, attending the event. You understand that there are inherent risks associated with participation in football games and the participation of you and your child in the event and you fully accept and agree to bear those risks. You grant the event staff permission to take your child to a hospital, administer first aid or call for an ambulance in the event of any illness or injury during participation in the event.
- 2.3** Please state any medical/health conditions of which we need to be aware.
- 2.4** You agree not to bring any claim or proceeding against Football Australia (FA), Australian Professional Leagues (APL) or the Club or each of their employees or volunteers for the event for any damage, loss, injury or liability you or your child may suffer from participating in the event. Except for liability that by law cannot be excluded, FA, APL and the Club exclude all liability to you and your child for acts or omissions of FA, APL, the Club and their employees and volunteers arising out of or in relation to the event.
- 2.5** You acknowledge and agree that media will be present at the event and you consent to the media, FA, APL and the Club (and any third party acting on their behalf), without compensation, using, reproducing, publishing and broadcasting your and/or your child's name, image and/or voice recording (including in any photograph, voice, sound or film recording or in any electronic representation) (Image) to the public, of an incidental nature or otherwise,:
- a.** In any media, including without limitation:
 - b.** internet websites (including social media websites such as Facebook, Twitter, LinkedIn and YouTube, Snapchat, news websites and websites such as wanderland.com.au (including making footage available for download on those websites);
 - c.** television;
 - d.** radio;
 - e.** print and news media; and
 - f.** For purposes including but not limited to, internal business purposes, marketing and advertising purposes, publicity, social media and illustration.

- 2.6** You acknowledge and agree that copyright and all associated rights in any photograph, voice, sound or film recording or in any electronic representation arising from the event that incorporates your and/or your child's Image is owned by FA, APL, the Club or the relevant media source (as applicable).
- 2.7** The Club respects the privacy of individuals about whom we collect personal information. - 2.8** You acknowledge that the information you provide will be collected by the Club and maybe disclosed to other third parties for the purposes outlined above or as required by law. Without the personal details of you and your child, we can't permit your Child to participate in the event.
